Proposal to Create a Western Wellness Centre Facility

Purpose of Report:	For Information
Date:	22 August 2017

The University's Long-Range Space (see Table 14 in Western's Budget Document) includes the modernization of Thames Hall – a centrally-located building on campus. The Thames Hall Project is an ideal opportunity to create an integrated Western Wellness Centre (WWC) that will provide a one-stop-shop facility that covers all aspects of student physical and mental health support services.

The proposed WWC Facility Project is as follows:

- Provide 22,000 net square feet of space for the WWC in Thames Hall – which provides incremental space (compared to the current space occupied by the units involved).
- This would allow for the consolidation of Student Health Services and Psychological Services into a single space. Discussions about other services that could possibly be included are underway – led by the Provost. However, all activities must be accommodated within the 22,000 sqft.
- The WWC will be created in large open and contiguous spaces within Thames Hall (i.e. the former pool, gym, and locker room areas) – thus allowing for custom design that is state-of-the art and flexible.
- Thames Hall will also house the School of Kinesiology and general use spaces and student study spaces.
- The WWC would be designed/constructed with its own entrance.

Estimated Costs

- The estimated cost of the full Thames Hall Project is about \$35 million – and within this, the WWC component is estimated to be \$20 million.
- The WWC's incremental space (compared to the current space of the units involved) will have incremental operating costs – estimated at about \$80,000 to \$100,000 per year.

Proposed Funding Plan

It is proposed that the WWC Facility project be funded jointly by the University and Western's students – as follows:

1. The University and the students (graduates, undergraduates, and the affiliated university college students) strike an equal partnership in financing the WWC – i.e. \$10 million each for the construction cost and 50% of the estimated incremental operating costs.
2. The students' \$10 million contribution could be achieved through a fee (approved by referendum) that lasts 10 years. The fee would start at \$36 per student in year one and increased by 2% each year for inflation. In year 10, the fee would be about \$43.
3. The present value of fee revenue collected over the 10-year period is estimated to be \$10.5 million – which covers the \$10 million construction cost and 50% of the operating costs over this period.



4. The University would fund its share of the construction cost (i.e. \$10 million) by borrowing the funds and its share of the incremental operating costs (i.e. total of about \$500,000) will be covered by the University's operating budget in each of the 10 years.

#### Other Related Issues

- a. The Thames Hall Project needs to get underway soon – and therefore we need commitments by mid-September from SOGS and the USC to take this forward to referendum.
- b. If the project moves forward with support from SOGS and the USC, the project planning committee (that works with the chosen architects) will include a representative from each of SOGS and the USC.



### Motion 3

#### Advocacy by USC for increased pedestrian and cyclist safety

Whereas, on September 8, 2017, the Western Gazette published an article highlighting concerns and issues around safety for cyclists and pedestrians on campus, after a collision between a motor vehicle and a cyclist on September 5, 2017.

Whereas, despite the address of pedestrian and cyclist safety in the 2016-17 USC advocacy papers, pedestrian/cyclist safety appears to be a continual concern for students.

Be it resolved that the USC begin setting clear milestones for the implementation of some recommendations as outlined in the 2016-17 advocacy paper.

Be it further resolved that the USC consider adding to the recommendations mentioned in the 2016-17 USC advocacy papers, to include initiatives such as scramble crossings (see Appendix 1) at major Western intersections including but not limited to: Western Rd. and Sarnia Rd., Western Rd., and Lambton Dr., and Lambton Dr. and University Dr.

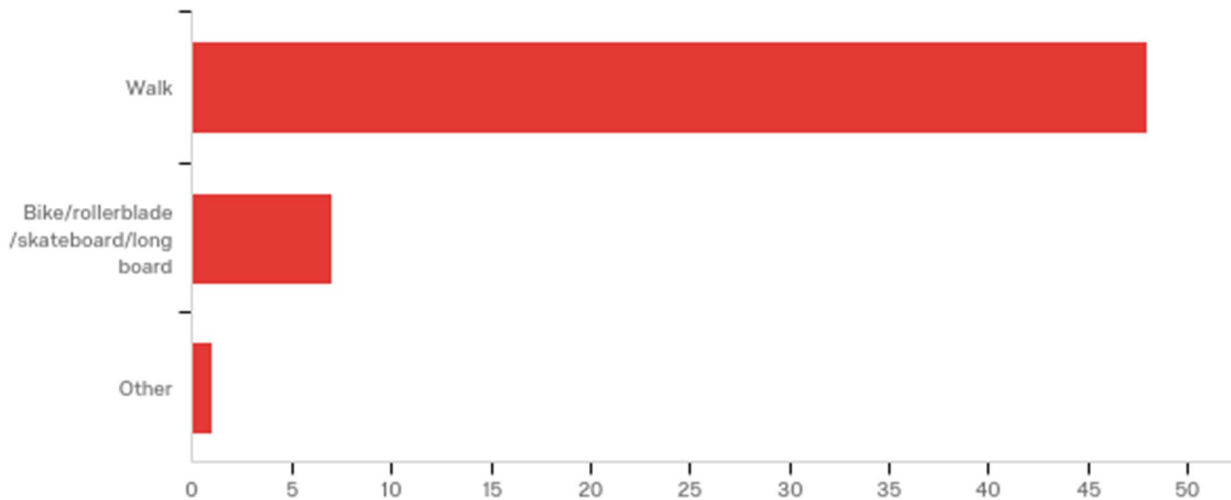

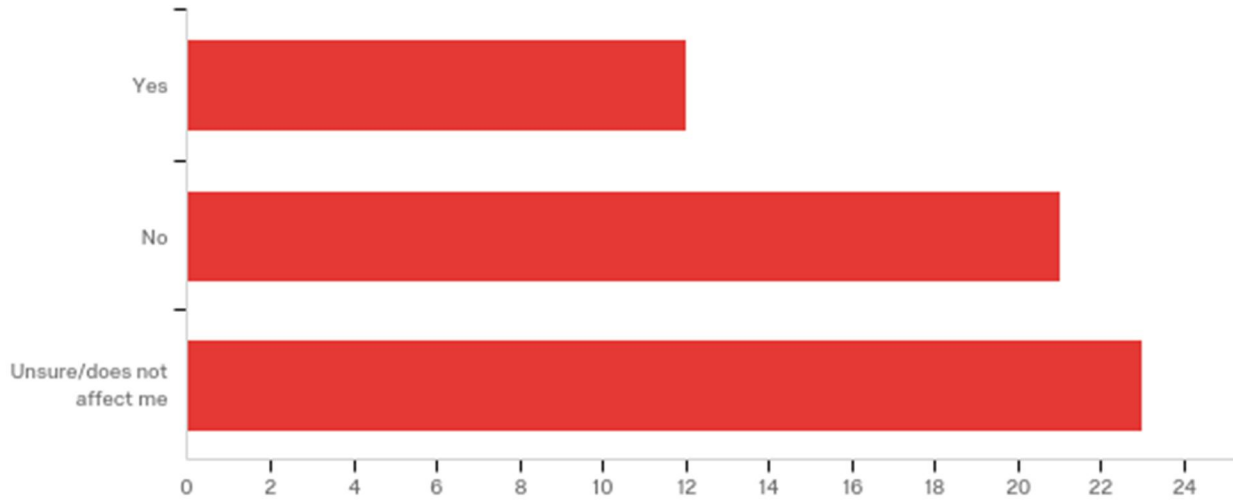

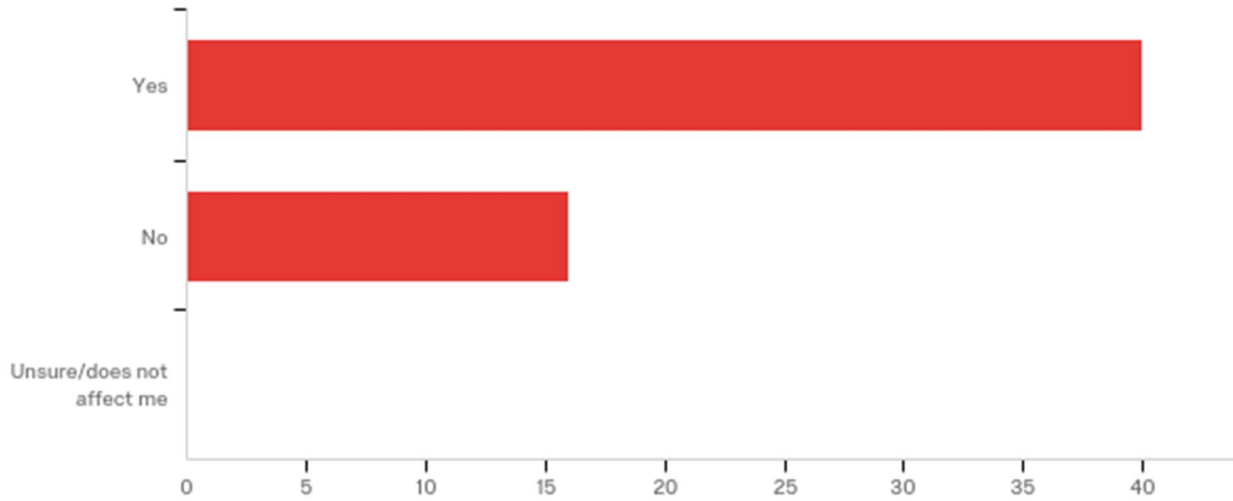
Q2 - Do you feel that Western has adequate/safe bike paths?

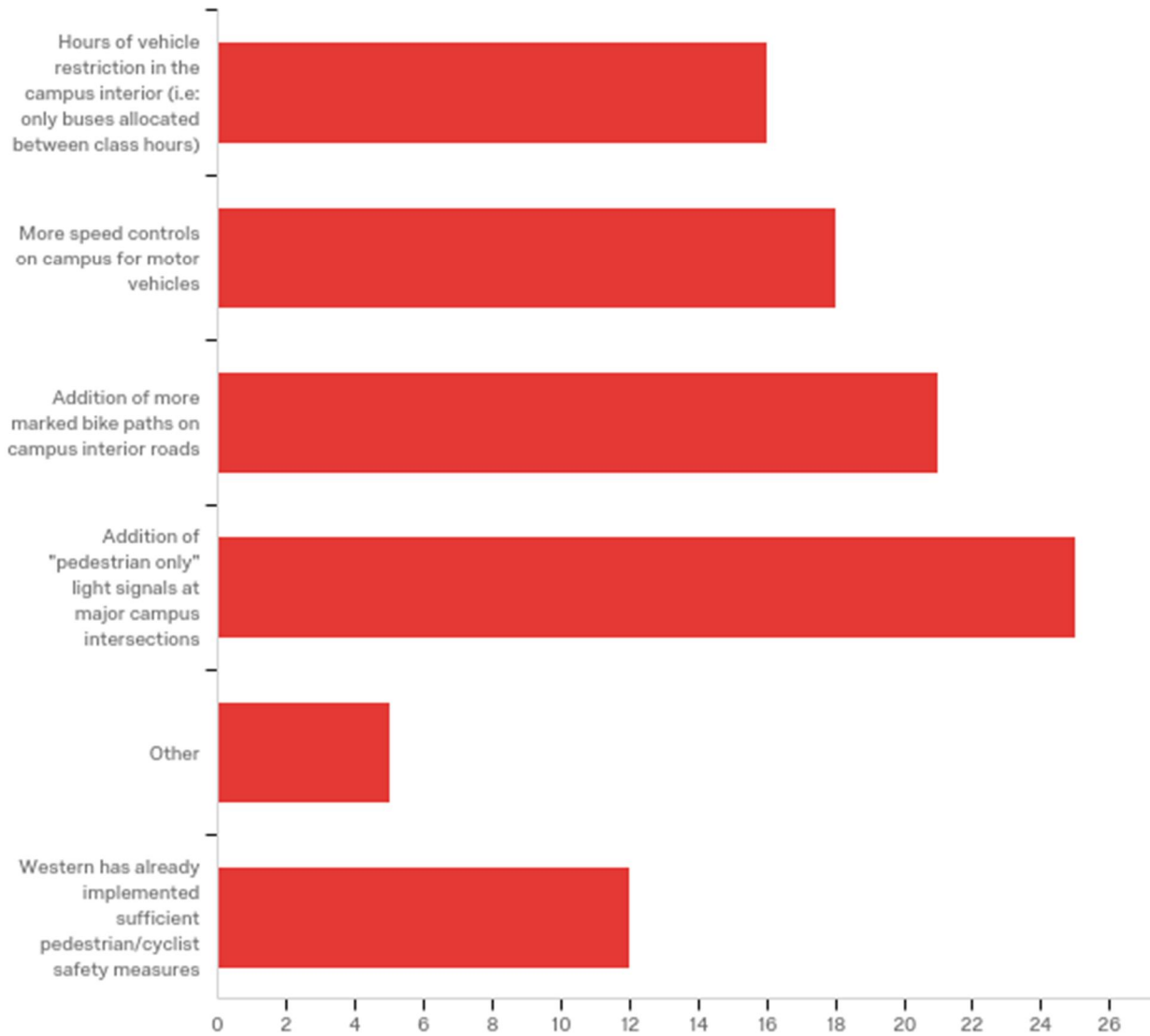
Q3 - Do you feel that Western has adequate/safe pedestrian crosswalks?

Appendix 4

Principles of Collaboration and Commitment

BETWEEN

The Western University Student Senators

AND

The University Students' Council of the University of Western Ontario

These Principles of Collaboration and Commitment are hereby articulated between the Western Student Senators hereinafter referred to as WSS, and University Students' Council of The University of Western Ontario, hereinafter referred to as the USC.

A. PURPOSE:

The purpose of articulating these Principles of Collaboration and Commitment is to set out a framework of cooperation between the WSS and the USC to develop mutually beneficial programs, advocacy priorities, projects and other engagement mechanisms in support of creating a better campus for all of Western undergraduate students.

B. PRINCIPLES GOVERNING THE RELATIONSHIP:

1. The WSS and the USC acknowledge, respect, and value the distinct yet complementary roles each plays within Western University.
2. The WSS and the USC are at their best when both parties commit to inspiring, challenging and collaborating as colleagues, and governing relations informed by a mutually beneficial partnership.
3. The WSS and the USC believe that successful collaborative partnerships require time, commitment, compromise, and mutual respect.

C. STATEMENT OF MUTUAL BENEFITS AND INTERESTS:

- A consistently professional, positive, and productive relationship.
- Stronger empathy and understanding of the challenges and limitations of each party, and a commitment to assisting to address them.
- Consistent and reliable partnership to strengthen lobby priorities and advocacy to the university administration and Senate.
- Broader recognition of the strengths of each partner, and a willingness to capitalize on those strengths to face common challenges, and pursue common opportunities.

D. STATEMENT OF COMMITMENT

The WSS shall:

1. Commit to monthly meetings between the Chair (or designate) and the USC (Vice-President and or designate) to review the relationship, assess progress of ongoing projects, and set new goals for the expansion of the relationship.
2. Invite the USC Vice-President (or designate) to attend WSS caucus meetings as a resource member.
3. After their election, the incoming Chair and Vice-President shall meet to discuss goals for the year, potential areas for collaboration, and outline their vision for the relationship.



4. Allow for the appointment of appropriate USC individuals (Vice-President or designate) to WSS caucus sub-committees where deemed appropriate by both parties.
5. Joint project teams may be established from time to time to pursue common goals and initiatives.
6. Have sole discretion as to how the USC budgetary allocation for WSS will be utilized and budgetary changes will be negotiated through the USC budget cycle.
7. Send one delegate to all USC council meetings to present relevant updates.
8. Acknowledge the unique and legitimate role the University Students' Council plays as an advocate for Western students in the community
9. Support the USC to accomplish its mission to "enhance the educational experience and quality of life for all undergraduates at Western University," and accomplish priorities contained within the USC's long-term strategic plan, to the extent WSS is in agreement with them.
10. Commit to strong communication between the two organizations about any relevant information which would impact either organization. The WSS will further commit to work with the USC on the principle of 'no surprises.'
11. Seek to engage with the USC on Senate matters which would directly affect Western students.
12. Attempt to find common-ground on submissions to the university, in order to portray a united student front.

USC shall:

1. Commit to monthly meetings with WSS leadership to review the relationship, assess progress of ongoing projects, and set new goals for the expansion of the relationship.
2. After their election, the incoming Chair and Vice-President shall meet to discuss goals for the year, potential areas for collaboration, and outline their vision for the relationship.
3. Appoint appropriate individuals (Vice-President or designate) to the WSS caucus sub-committees.
4. Joint project teams may be established from time to time to pursue common goal and initiatives.
5. Allocate an initial budgetary amount of \$1500 for the WSS in the USC budget to increase its organizational capacities. WSS will have sole discretion as to how the money will be allocated and any budgetary increases will be presented to USC Council for approval. Each year, the mandated base amount will be \$1500. Any increase agreed to by Council will become the baseline funding amount throughout the terms of this agreement (i.e. if Council approves an \$1000 increase, the baseline funding will become \$2500). The USC and WSS will not consider its respective political stances when approving budgetary changes.
6. Recognize and respect the fundamental role that the WSS plays in representing Western University students at the university Senate.
7. Commit to strong communication between the two organizations about any relevant information which would impact either organization. The USC will further commit to work with the WSS on the principle of 'no surprises.'
8. Support the WSS to gather student feedback on any pertinent issues relating to students as determined by the WSS and agree to share previously collected feedback that is pertinent to achieving common goals
9. Grant WSS similar abilities and privileges as Faculty Councils including, but not limited to, booking UCC conference rooms, atrium booths, and receiving guidance from members of the Executive on portfolio-related initiatives.
10. Attempt to find common-ground on submissions to the university, in order to portray a united student front.

E. TERMS OF AGREEMENT

The agreement shall begin immediately upon its signing and will cease exactly three (3) years to the day it was signed. Additionally, the agreement shall be dissolved upon the written consent of each party.





In the third year of the agreement, the WSS Chair and USC Vice-President shall meaningfully attempt to negotiate a new agreement. Alternatively, they may elect to a three (3) year continuance of the current agreement.

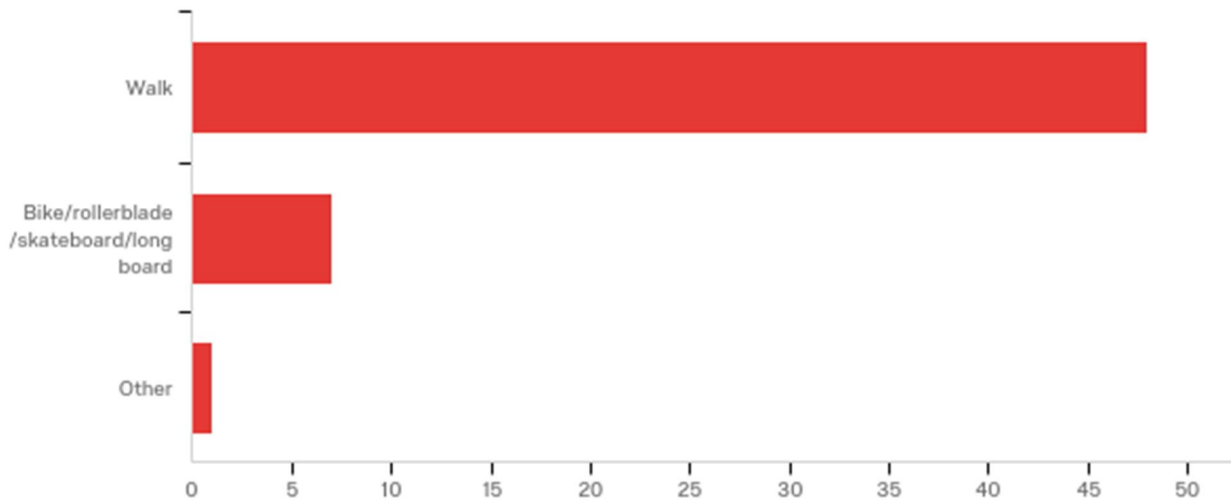

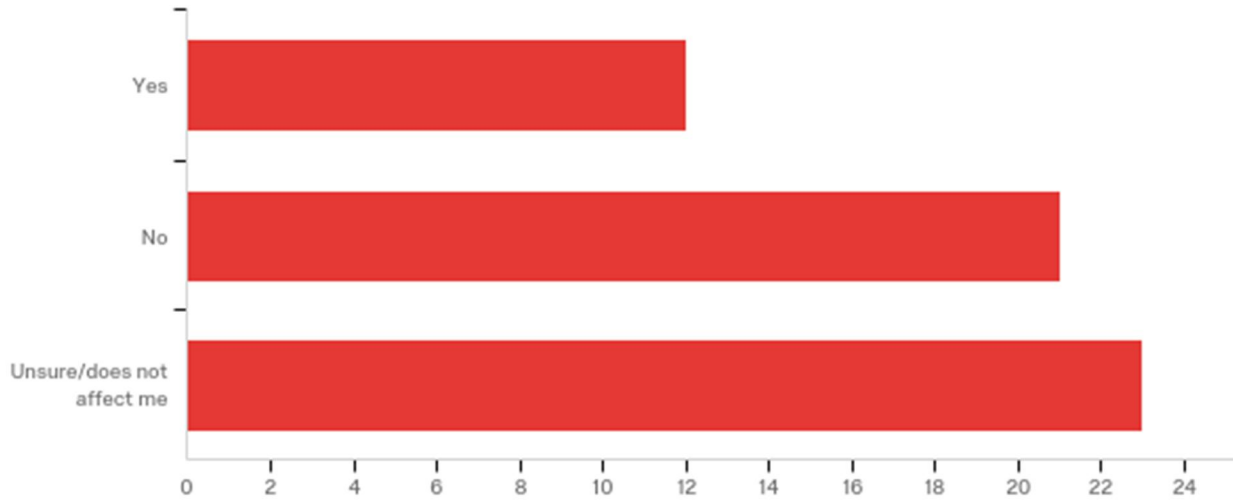
Q1 - What is the main mode of transportation you utilize AROUND campus?

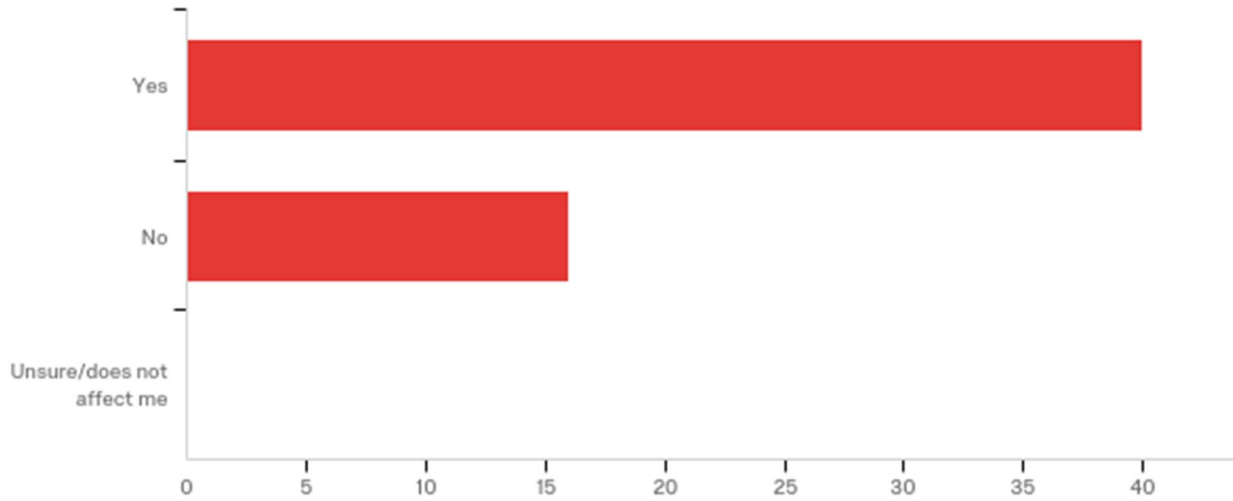
Q2 - Do you feel that Western has adequate/safe bike paths?

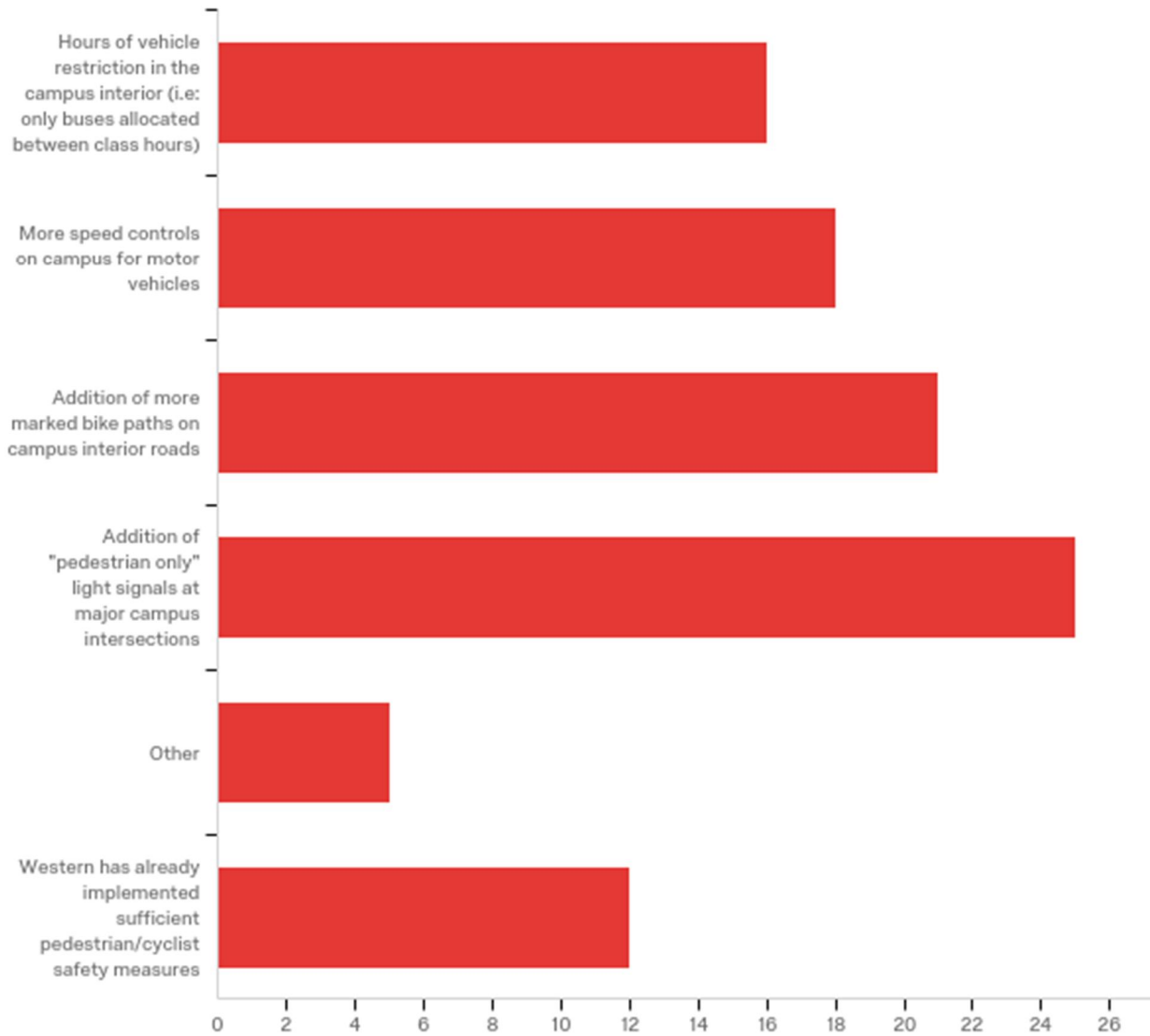
Q3 - Do you feel that Western has adequate/safe pedestrian crosswalks?

- Broader recognition of the strengths of each partner, and a willingness to capitalize on those strengths to face common challenges, and pursue common opportunities.

D. STATEMENT OF COMMITMENT

The WSS shall:

1. Commit to monthly meetings between the Chair (or designate) and the USC (Vice-President and or designate) to review the relationship, assess progress of ongoing projects, and set new goals for the expansion of the relationship.
2. Invite the USC Vice-President (or designate) to attend WSS caucus meetings as a resource member.
3. After their election, the incoming Chair and Vice-President shall meet to discuss goals for the year, potential areas for collaboration, and outline their vision for the relationship.





4. Allow for the appointment of appropriate USC individuals (Vice-President or designate) to WSS caucus sub-committees where deemed appropriate by both parties.
5. Joint project teams may be established from time to time to pursue common goals and initiatives.
6. Have sole discretion as to how the USC budgetary allocation for WSS will be utilized and budgetary changes will be negotiated through the USC budget cycle.
7. Send one delegate to all USC council meetings to present relevant updates.
8. Acknowledge the unique and legitimate role the University Students' Council plays as an advocate for Western students in the community
9. Support the USC to accomplish its mission to “enhance the educational experience and quality of life for all undergraduates at Western University,” and accomplish priorities contained within the USC’s long-term strategic plan, to the extent WSS is in agreement with them.
10. Commit to strong communication between the two organizations about any relevant information which would impact either organization. The WSS will further commit to work with the USC on the principle of ‘no surprises.’
11. Seek to engage with the USC on Senate matters which would directly affect Western students.
12. Attempt to find common-ground on submissions to the university, in order to portray a united student front.

USC shall:

1. Commit to monthly meetings with WSS leadership to review the relationship, assess progress of ongoing projects, and set new goals for the expansion of the relationship.
2. After their election, the incoming Chair and Vice-President shall meet to discuss goals for the year, potential areas for collaboration, and outline their vision for the relationship.
3. Appoint appropriate individuals (Vice-President or designate) to the WSS caucus sub-committees.
4. Joint project teams may be established from time to time to pursue common goal and initiatives.
5. Allocate an initial budgetary amount of \$1500 for the WSS in the USC budget to increase its organizational capacities. WSS will have sole discretion as to how the money will be allocated and any budgetary increases will be presented to USC Council for approval. Each year, the mandated base amount will be \$1500. Any increase agreed to by Council will become the baseline funding amount throughout the terms of this agreement (i.e. if Council approves an \$1000 increase, the baseline funding will become \$2500). The USC and WSS will not consider its respective political stances when approving budgetary changes.
6. Recognize and respect the fundamental role that the WSS plays in representing Western University students at the university Senate.
7. Commit to strong communication between the two organizations about any relevant information which would impact either organization. The USC will further commit to work with the WSS on the principle of ‘no surprises.’
8. Support the WSS to gather student feedback on any pertinent issues relating to students as determined by the WSS and agree to share previously collected feedback that is pertinent to achieving common goals
9. Grant WSS similar abilities and privileges as Faculty Councils including, but not limited to, booking UCC conference rooms, atrium booths, and receiving guidance from members of the Executive on portfolio-related initiatives.
10. Attempt to find common-ground on submissions to the university, in order to portray a united student front.

E. TERMS OF AGREEMENT

The agreement shall begin immediately upon its signing and will cease exactly three (3) years to the day it was signed. Additionally, the agreement shall be dissolved upon the written consent of each party.



In the third year of the agreement, the WSS Chair and USC Vice-President shall meaningfully attempt to negotiate a new agreement. Alternatively, they may elect to a three (3) year continuance of the current agreement.

The University's Long-Range Space (see Table 14 in Western's Budget Document) includes the modernization of Thames Hall – a centrally-located building on campus. The Thames Hall Project is an ideal opportunity to create an integrated Western Wellness Centre (WWC) that will provide a one-stop-shop facility that covers all aspects of student physical and mental health support services.

The proposed WWC Facility Project is as follows:

- Provide 22,000 net square feet of space for the WWC in Thames Hall – which provides incremental space (compared to the current space occupied by the units involved).
- This would allow for the consolidation of Student Health Services and Psychological Services into a single space. Discussions about other services that could possibly be included are underway – led by the Provost. However, all activities must be accommodated within the 22,000 sqft.
- The WWC will be created in large open and contiguous spaces within Thames Hall (i.e. the former pool, gym, and locker room areas) – thus allowing for custom design that is state-of-the art and flexible.
- Thames Hall will also house the School of Kinesiology and general use spaces and student study spaces.
- The WWC would be designed/constructed with its own entrance.

Estimated Costs

- The estimated cost of the full Thames Hall Project is about \$35 million – and within this, the WWC component is estimated to be \$20 million.
- The WWC's incremental space (compared to the current space of the units involved) will have incremental operating costs – estimated at about \$80,000 to \$100,000 per year.

Proposed Funding Plan

It is proposed that the WWC Facility project be funded jointly by the University and Western's students – as follows:

1. The University and the students (graduates, undergraduates, and the affiliated university college students) strike an equal partnership in financing the WWC – i.e. \$10 million each for the construction cost and 50% of the estimated incremental operating costs.
2. The students' \$10 million contribution could be achieved through a fee (approved by referendum) that lasts 10 years. The fee would start at \$36 per student in year one and increased by 2% each year for inflation. In year 10, the fee would be about \$43.
3. The present value of fee revenue collected over the 10-year period is estimated to be \$10.5 million – which covers the \$10 million construction cost and 50% of the operating costs over this period.



4. The University would fund its share of the construction cost (i.e. \$10 million) by borrowing the funds and its share of the incremental operating costs (i.e. total of about \$500,000) will be covered by the University's operating budget in each of the 10 years.

#### Other Related Issues

- a. The Thames Hall Project needs to get underway soon – and therefore we need commitments by mid-September from SOGS and the USC to take this forward to referendum.
- b. If the project moves forward with support from SOGS and the USC, the project planning committee (that works with the chosen architects) will include a representative from each of SOGS and the USC.





### Motion 3

#### Advocacy by USC for increased pedestrian and cyclist safety

Whereas, on September 8, 2017, the Western Gazette published an article highlighting concerns and issues around safety for cyclists and pedestrians on campus, after a collision between a motor vehicle and a cyclist on September 5, 2017.

Whereas, despite the address of pedestrian and cyclist safety in the 2016-17 USC advocacy papers, pedestrian/cyclist safety appears to be a continual concern for students.

Be it resolved that the USC begin setting clear milestones for the implementation of some recommendations as outlined in the 2016-17 advocacy paper.

Be it further resolved that the USC consider adding to the recommendations mentioned in the 2016-17 USC advocacy papers, to include initiatives such as scramble crossings (see Appendix 1) at major Western intersections including but not limited to: Western Rd. and Sarnia Rd., Western Rd., and Lambton Dr., and Lambton Dr. and University Dr.

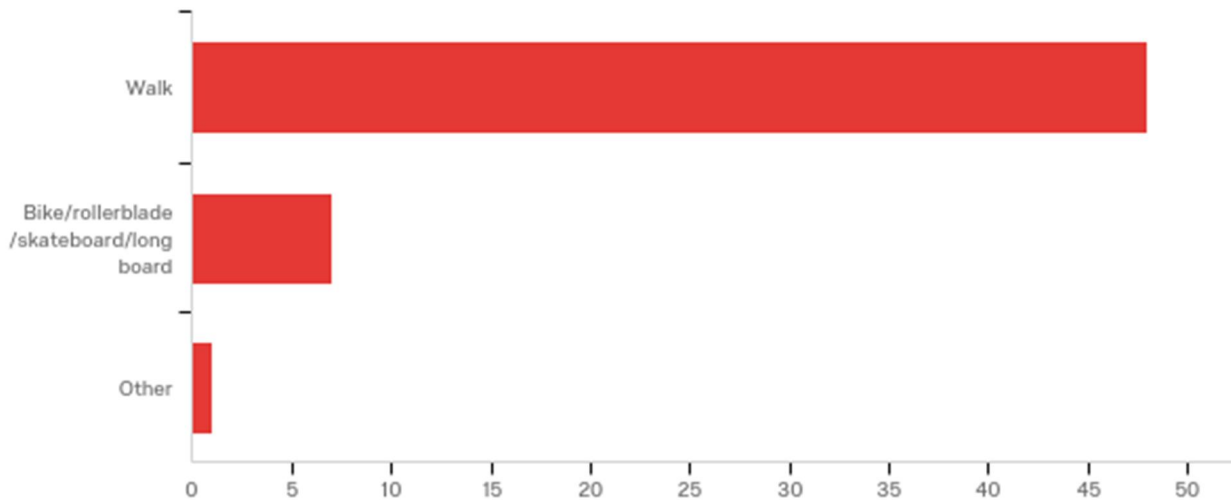

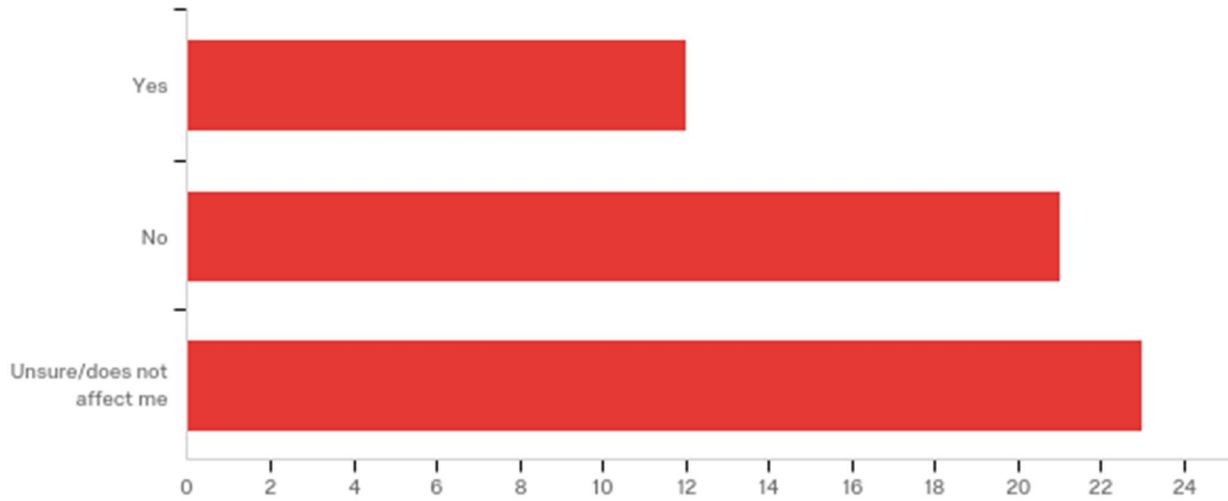

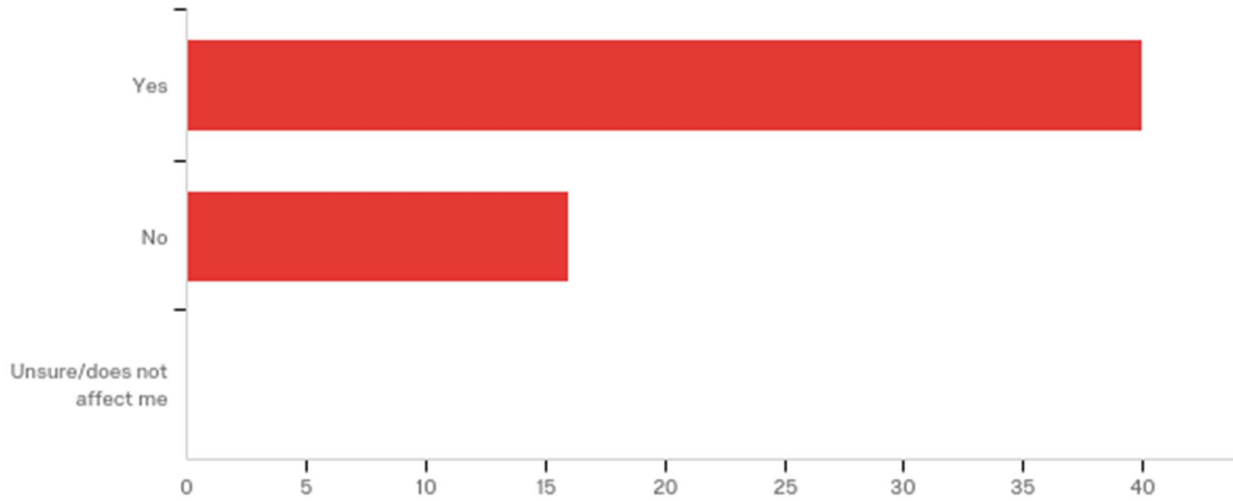
Q2 - Do you feel that Western has adequate/safe bike paths?

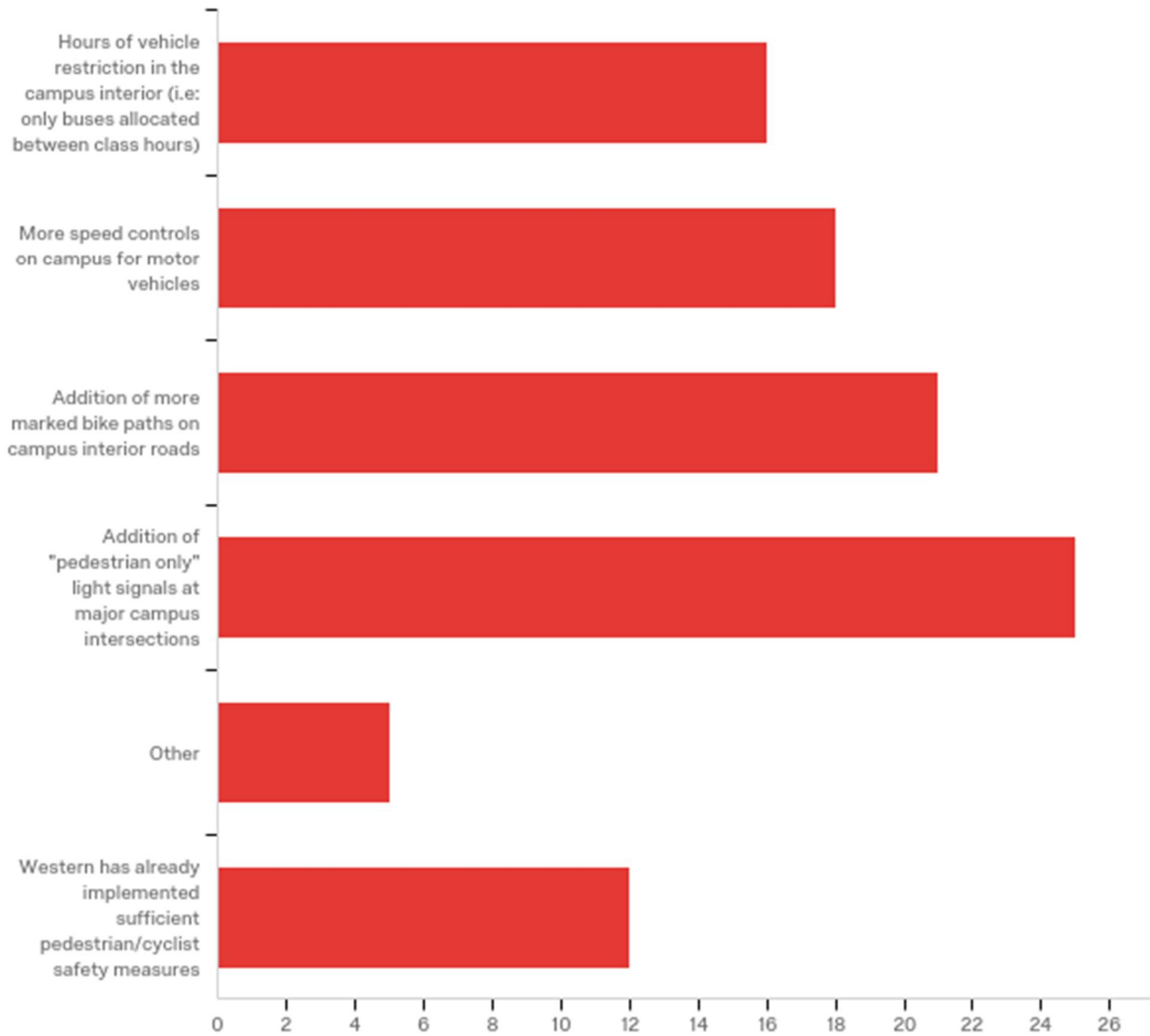
Q3 - Do you feel that Western has adequate/safe pedestrian crosswalks?

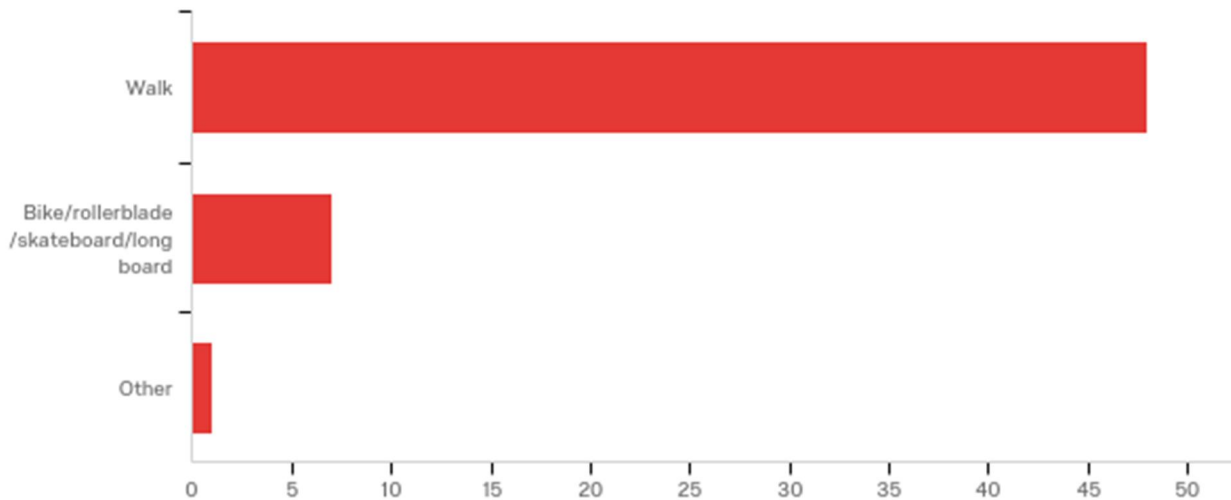

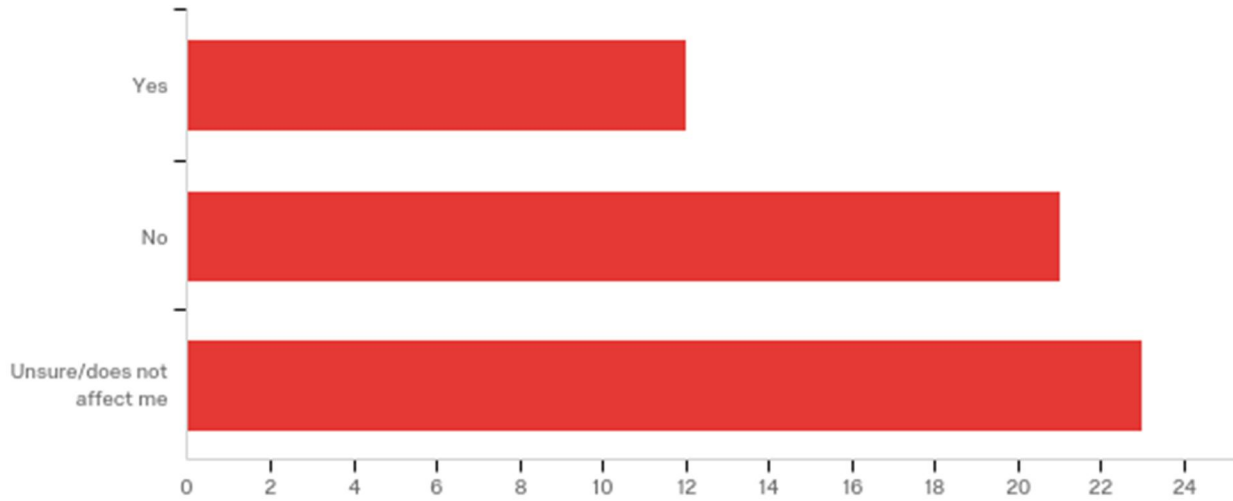

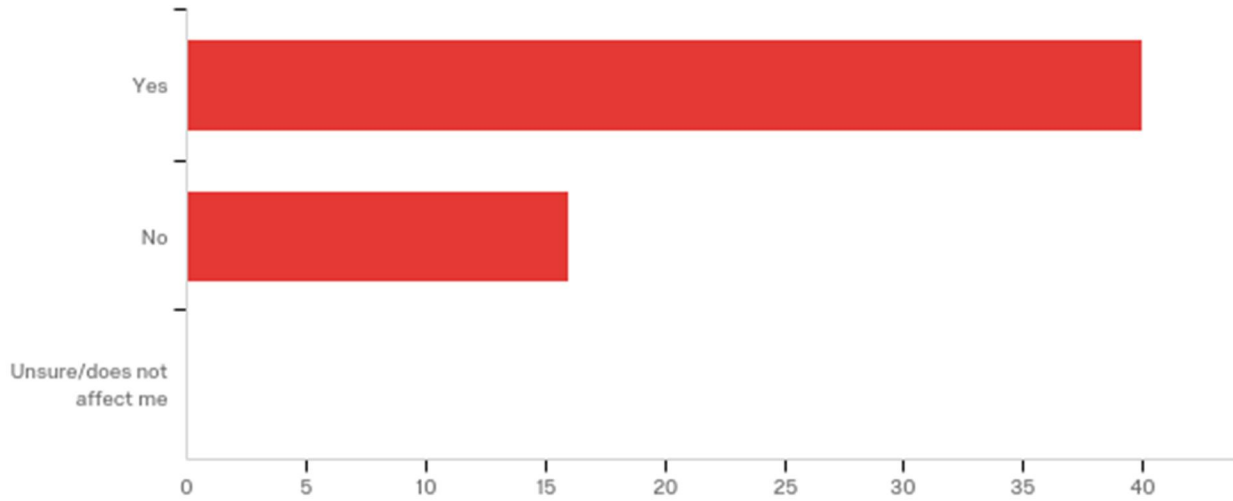

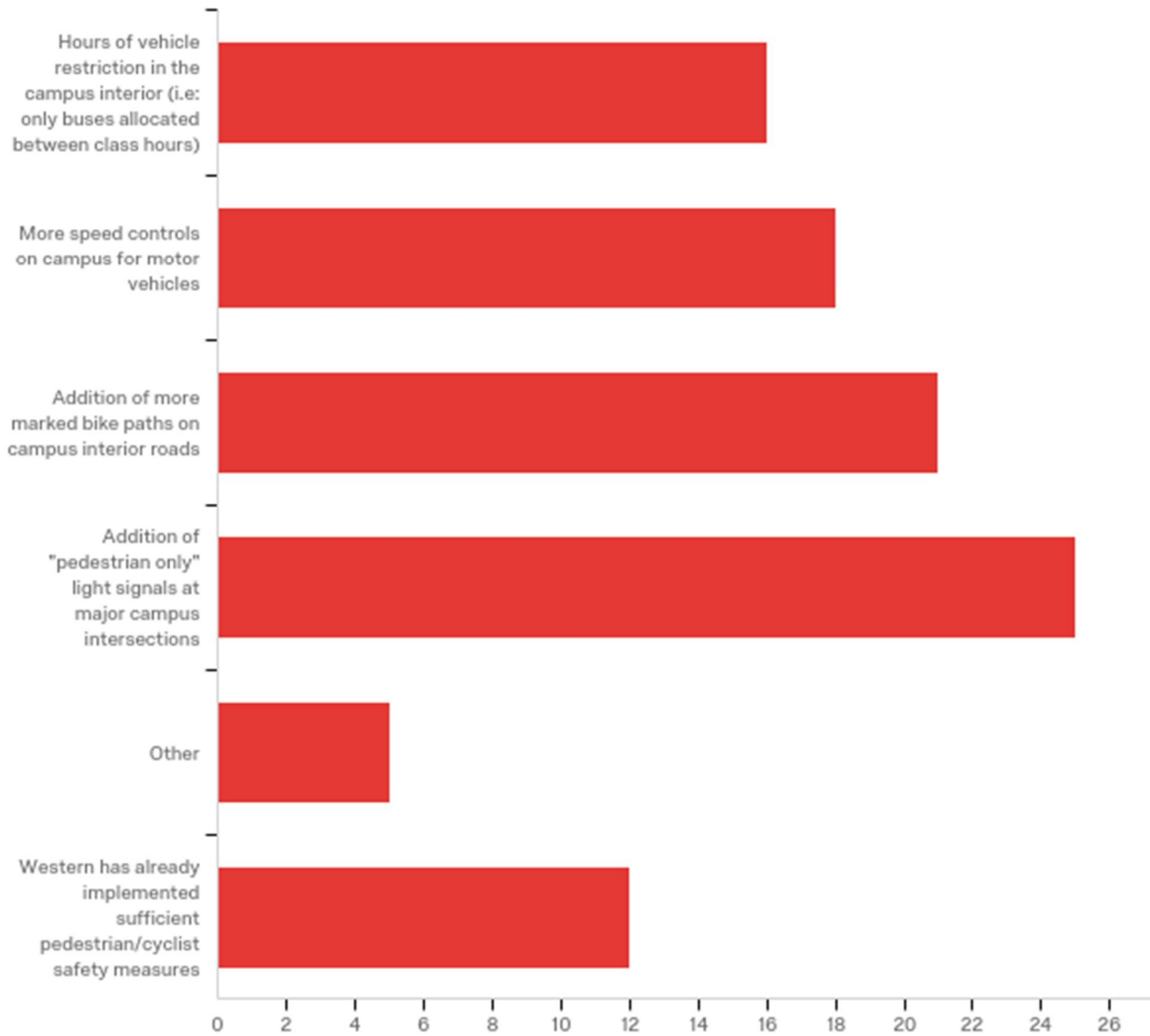
Q3 - Do you feel that Western has adequate/safe pedestrian crosswalks?

Appendix 4

Principles of Collaboration and Commitment

BETWEEN

The Western University Student Senators

AND

The University Students' Council of the University of Western Ontario

These Principles of Collaboration and Commitment are hereby articulated between the Western Student Senators hereinafter referred to as WSS, and University Students' Council of The University of Western Ontario, hereinafter referred to as the USC.

A. PURPOSE:

The purpose of articulating these Principles of Collaboration and Commitment is to set out a framework of cooperation between the WSS and the USC to develop mutually beneficial programs, advocacy priorities, projects and other engagement mechanisms in support of creating a better campus for all of Western undergraduate students.

B. PRINCIPLES GOVERNING THE RELATIONSHIP:

1. The WSS and the USC acknowledge, respect, and value the distinct yet complementary roles each plays within Western University.
2. The WSS and the USC are at their best when both parties commit to inspiring, challenging and collaborating as colleagues, and governing relations informed by a mutually beneficial partnership.
3. The WSS and the USC believe that successful collaborative partnerships require time, commitment, compromise, and mutual respect.

C. STATEMENT OF MUTUAL BENEFITS AND INTERESTS:

- A consistently professional, positive, and productive relationship.
- Stronger empathy and understanding of the challenges and limitations of each party, and a commitment to assisting to address them.
- Consistent and reliable partnership to strengthen lobby priorities and advocacy to the university administration and Senate.
- Broader recognition of the strengths of each partner, and a willingness to capitalize on those strengths to face common challenges, and pursue common opportunities.

D. STATEMENT OF COMMITMENT

The WSS shall:

1. Commit to monthly meetings between the Chair (or designate) and the USC (Vice-President and or designate) to review the relationship, assess progress of ongoing projects, and set new goals for the expansion of the relationship.
2. Invite the USC Vice-President (or designate) to attend WSS caucus meetings as a resource member.
3. After their election, the incoming Chair and Vice-President shall meet to discuss goals for the year, potential areas for collaboration, and outline their vision for the relationship.



4. Allow for the appointment of appropriate USC individuals (Vice-President or designate) to WSS caucus sub-committees where deemed appropriate by both parties.
5. Joint project teams may be established from time to time to pursue common goals and initiatives.
6. Have sole discretion as to how the USC budgetary allocation for WSS will be utilized and budgetary changes will be negotiated through the USC budget cycle.
7. Send one delegate to all USC council meetings to present relevant updates.
8. Acknowledge the unique and legitimate role the University Students' Council plays as an advocate for Western students in the community
9. Support the USC to accomplish its mission to "enhance the educational experience and quality of life for all undergraduates at Western University," and accomplish priorities contained within the USC's long-term strategic plan, to the extent WSS is in agreement with them.
10. Commit to strong communication between the two organizations about any relevant information which would impact either organization. The WSS will further commit to work with the USC on the principle of 'no surprises.'
11. Seek to engage with the USC on Senate matters which would directly affect Western students.
12. Attempt to find common-ground on submissions to the university, in order to portray a united student front.

USC shall:

1. Commit to monthly meetings with WSS leadership to review the relationship, assess progress of ongoing projects, and set new goals for the expansion of the relationship.
2. After their election, the incoming Chair and Vice-President shall meet to discuss goals for the year, potential areas for collaboration, and outline their vision for the relationship.
3. Appoint appropriate individuals (Vice-President or designate) to the WSS caucus sub-committees.
4. Joint project teams may be established from time to time to pursue common goal and initiatives.
5. Allocate an initial budgetary amount of \$1500 for the WSS in the USC budget to increase its organizational capacities. WSS will have sole discretion as to how the money will be allocated and any budgetary increases will be presented to USC Council for approval. Each year, the mandated base amount will be \$1500. Any increase agreed to by Council will become the baseline funding amount throughout the terms of this agreement (i.e. if Council approves an \$1000 increase, the baseline funding will become \$2500). The USC and WSS will not consider its respective political stances when approving budgetary changes.
6. Recognize and respect the fundamental role that the WSS plays in representing Western University students at the university Senate.
7. Commit to strong communication between the two organizations about any relevant information which would impact either organization. The USC will further commit to work with the WSS on the principle of 'no surprises.'
8. Support the WSS to gather student feedback on any pertinent issues relating to students as determined by the WSS and agree to share previously collected feedback that is pertinent to achieving common goals
9. Grant WSS similar abilities and privileges as Faculty Councils including, but not limited to, booking UCC conference rooms, atrium booths, and receiving guidance from members of the Executive on portfolio-related initiatives.
10. Attempt to find common-ground on submissions to the university, in order to portray a united student front.

E. TERMS OF AGREEMENT

The agreement shall begin immediately upon its signing and will cease exactly three (3) years to the day it was signed. Additionally, the agreement shall be dissolved upon the written consent of each party.



In the third year of the agreement, the WSS Chair and USC Vice-President shall meaningfully attempt to negotiate a new agreement. Alternatively, they may elect to a three (3) year continuance of the current agreement.
