## **Motion 1**

## Motion to Amend the Councillor Accountability and Discipline Procedure

**Whereas,** Councillors are required to represent their constituents throughout their terms on Council and are expected to attend all meetings or send a proxy in their place.

Whereas, existing accountability and discipline procedures have not been effective at further educating Councillors regarding their responsibilities and disciplining those who do not meet expectations.

**Be it resolved,** that Council approve the proposed amendments to the Councillor Accountability and Discipline Procedure (**Appendix A**).

**Be it resolved that** the USC form a working group to assess the various forms of oppression which Western students face;

**Be it further resolved that** this working group produce recommendations to guide USC advocacy and initiatives no later than the end of the 2020 Fall term;

**Be it further resolved that** this working group consult each peer program, interfaith club, and ethnocultural club on campus, including, but not limited to, those identified in the *Formal Consultation Process Mandatory Guidelines* as well as mature students;

Be it further resolved that this working group be composed of one (1) Chair, and four (4) General Members.

**Be it further resolved** that this working group be composed of four (4) Councilors and four (4) Students-at-Large as elected by Council

**Be it further resolved** that this working group offer relevant representatives from USC-ratified stakeholders and Resource Member positions on the Working Group.

**Be it resolved that** the USC form a working group to formulate a new Environmentalism & Sustainability Policy to oversee Council operations;

**Be it further resolved that** this working group produce such a policy no later than the end of the 2021 Winter term:

**Be it further resolved that** this working group consult with relevant stakeholders, including but not limited to the Indigenous Students' Association;

**Be it further resolved that** this working group be composed of four (4) Councilors and four (4) Students-at-Large as elected by Council

Be it further resolved that one (1) Chair is internally elected



**Be it further resolved that** this working group offer relevant representatives from USC-ratified stakeholders (including, but not limited to, EnviroWestern and Student Energy at Western) and Resource Member positions on the Working Group.

Motion 6

Sexual and Gender-Based Violence Working Group

**Whereas** the 2018 report from the Council of Ontario Universities (COU) <sup>1</sup> indicated that 71 percent of Western University student participants have experienced sexual harassment and 31 percent have experienced sexual assault, thus confirming that sexualized violence is a prevalent reality and concern on our campus.

**Whereas** social distancing measures in light of COVID-19 indicate an increased amount of time spent in residences increasing the potential for sexualized violence.

**Whereas** addressing on-campus sexual harassment and assault has been indicated as a priority for the 2020-21 USC body.

**Whereas** Councillors Alie and Campbell have formed a group to research the prevalence of sexual violence in residence and on-campus, in regard to the new Gender-based and Sexual Violence Policy that came into effect on May 1st, 2020 <sup>2</sup>, as well as the implementation of said policy and procedure through both Western Housing and COVID-19 lenses.

**Be it resolved** that this group be recognized as an official working group in order to task the Executive with SCBV-related advocacy.

**Be it resolved that** the composition of the working group will include those already working on the group, with up to four (4) additional Councillors to be elected by Council.

**Be it further resolved that** this working group include four (4) students at large to be elected by Council to sit as resource members.

## Motion 7

Motion: Advocacy for Increased Student Affordability during COVID-19

**Whereas** COVID-19 will have a lasting negative impact<sup>3</sup> on many students' income streams for the foreseeable future:

**Whereas** education quality and the student experience are likely to decrease next term as a direct result of the pandemic while the cost of tuition remains unchanged;

**Be it resolved that** Council task the USC Executive with advocating for increased education affordability, with particular emphasis on calls to the federal and provincial governments to provide universities with subsidies to decrease tuition, and calls to Western University to increase the amount of available scholarships and expand bursary eligibility for the 2020-21 school year.

**Be it further resolved,** the USC Executive provide an update on their advocacy efforts and the progress of the working group at the 2020 September Council meeting and the Tuition Policy Paper be presented at the 2020 November Council Meeting.
