Board of Directors and Council

1. Objective

The University Students' Council Policy Plan is a guiding document that supervises the organization, implementation and revision of existing policy and procedures within the organization. It is designed to ensure public, guiding documents are continuously revised and revisited to maintain compliance and relevance within the organization.

2. Scope

All documents made publically available on the USC's website are under the purview of the Policy Plan. The Council and Board of Directors can recommend the addition of new policy to fill a gap identified in the plan. They can also recommend the annulment of policy that is deemed to be redundant or outdated.

3. Jurisdiction

The Policy Plan will be under the jurisdiction of both Council and the Board of Directors. Substantive changes made to the document require joint-approval. The Policy Plan outlines the specific documents which fall under either body's purview. Such documents can be unilaterally reviewed, annulled or amending.

Documents that fall under joint-jurisdiction require both Council and Board to conduct the review collaboratively.

4. Addition of Documents

During the period of review, the Council or Board may identify gaps. Either body can task the Secretary-Treasurer's office to investigate what necessary policies or procedures would be required to eliminate missing information or faults.

5. Review Timelines

Both the Council and Board of Directors can establish their own review timelines and schedules, upon recommendation of the Secretary-Treasurer. Reviews must occur at least every four (4) years, and can occur as often as every one (1) year.
