## Motion 2

### Elections Policy Reform

**Whereas** The USC has experienced procedural and perception-related challenges in the administration and oversight of election complaints;

**Whereas** trust in student elections depends on transparent, consistent, and independent complaint resolution processes;

**Whereas** the proposed *USC Electoral Code* and related governance reforms aim to improve structural oversight, streamline complaint triaging, and provide clear education and expectations for all candidates and elections adjudicators;

**Whereas** these changes are informed by legal counsel, operational review, and student consultation, and align with USC's broader commitment to democratic integrity;

**Be it resolved** that Council approves the implementation of the Electoral Code and accompanying elections governance reforms for the 2025 - 2026 elections cycle.

### Motion 3

#### **Amendments to the OUSA Delegate Selection Policy to Enable Affinity-Based Representation**

**Whereas:** The current USC delegate selection policy for OUSA General Assemblies does not include any provision for prioritizing the inclusion of students with lived experience related to equity-deserving groups when such communities are the subject of policy papers.

**Whereas:** This gap in representation risks undermining the effectiveness and legitimacy of the USC's advocacy at OUSA by failing to include voices with direct insight into the issues being debated.

**Be it resolved that:** Council approve an amendment to the OUSA Delegate Selection Policy to reserve one voting delegate seat for self-identifying students when a policy paper under consideration substantially addresses the concerns of an affinity or equity-deserving group

**Be it further resolved that:** This policy shall be implemented as a pilot for the Fall 2025 OUSA General Assembly and be subject to a formal review by April 2026, with a recommendation brought to Council no later than August 2026.
