**And Whereas:** Supporting engagement, accessibility, and sustainability in student governance is a priority of the University Student Council of the University of Western Ontario;

**Be it resolved that:** Council request that the Executive, in consultation with relevant USC operational leadership, assess the feasibility, governance considerations, and operational implications of potential non-monetary identification and recognition mechanisms for Faculty Councillors; and

**Be it further resolved that:** The feasibility review include consideration of standardized, non-monetary identification measures (such as a USC Councillor OneCard sticker model proposed); and

**Be it further resolved that:** The Executive report back to Council with findings and recommendations, including any limitations, risks, or approvals that would be required prior to implementation.
